# ***DENALI FAMILY SERVICES***

Our goal is to creatively provide mental health services for children, families and adults with emotional and behavioral problems in the Anchorage and Matanuska-Susitna Valley areas that experience significant emotional challenges. We work with parents, children, adults, health care providers and anyone relevant in our client's life to assist in reaching his/her life goals.



## ***ADULT SERVICES***

Transition Services for youth ages 21 years and counseling services for adults are also available.



## ***TRAINING & DEVELOPMENT***

DFS provides high-quality behavioral health training to our staff and the community. Advocates, parents, professionals, and paraprofessionals in educations, health and human services will find our curriculum and essential supplement to their knowledge base.



## ***LITTLE STEPS PRESCHOOL***

DFS operates a therapeutic childcare center in Anchorage providing quality early education and therapeutic care for young children who range in the ages from 1 - 5 years who experience emotional and behavioral problems.



## ***THERAPEUTIC FOSTER CARE***

Therapeutic Foster Care allows the child to remain in the community and is an effective alternative to residential care. It provides intensive therapeutic support in a family setting. DFS foster parents are trained and licensed to provide rehabilitation services for children and youth ages 3 - 19.



## ***CASE MANAGEMENT***

Mental health rehabilitative services are provided by participating in treatment planning. The case manager assists the client to obtain the proper services within the home, school and community.



## ***CLINICAL SERVICES***

The clinical Department provides individual group and family counseling as well as psychiatric assessments and medication management for adults and children. Our staff has a wide range of clinical specialties.



## ***COMMUNITY & SCHOOL BASED SERVICES***

Behavioral health services such as: individual skill development and group skill development activities are provided to assist in developing and maintaining a therapeutic relationship with clients and their families.
